

### Audits of annual and consolidated financial statements based on HGB / IFRS / US-GAAP

We handle the legally required audits of annual and consolidated financial statements, according to both German and European regulations, as well as international standards such as US-GAAP and IFRS. We also handle voluntary audits of annual and consolidated financial statements, as more and more banks, credit insurers, factoring companies and suppliers attach importance to audited annual financial statements. The rating generally improves considerably due to the transparency thus shown.

### Audits based on the German Regulation on Brokers and Developers (MaBV)

If brokers and property developers are required to carry out audits, we cover this legal requirement too.

### Audits under Article 53 of the German Act on Budgetary Principles (HGrG)

The insolvency courts and also the creditors of insolvent companies have the use of funds by the insolvency administrator externally audited in order to ensure transparency with respect to all creditor groups and the insolvency courts.

### Conversion of accounting from HGB to IFRS

## Merger audits






